Sealed tender affixing non-refundable Court Fee Stamp of Rs. 8.25 (Rupees eight and paisa twenty five) only are invited by the undersigned on behalf of the Director General of Civil Defence & Commandant General of Home Guards, Assam, Belotla, Guwahati-28 from the intending bidders for selling of fired empty cases.

The tenders will be received up to 02:00 P.M. on 14th May, 2015 and will be opened on the same day at 03:00 PM by the undersigned or by any other officer authorized by the DGCD & CGHG, Assam. The tenderers or their authorized representative may remain present at the time of opening of tender.

In case, the last date of receiving of tenders falls on holiday declared by the Govt. on any circumstance, the next working day will be treated as the last date of receiving of tenders.

A sum of Rs. 5,000.00 (Rupees five thousand) only in shape of Demand Draft or Bank Guarantee in favour of the Director General of Civil Defence & Commandant General of Home Guards, Assam, Beltola, Guwahati – 28 must be submitted along with the tender as earnest money.

The tender should be duly sealed and super-scribed on the envelop as “tender for fired Empty Cases”. The name of tenderer should also be written clearly on the envelop in left side.

Tender must be written in legible ink or typed clearly. There must not be any overwriting Rates should be quoted per kg.

The following documents should be submitted along with the tender.

1. Income Tax Clearance Certificate
2. VAT clearance Certificate.
3. PAN Card.

The undersigned is not bound to accept the highest rate and reserves the right to reject any or all the tenders without assigning any reason thereof.

The fired empty cases will have to be defaced by the approved tenderer (Purchaser) in presence of the officer duly designated by the DGCD.

All expenditure on defacing (Melting) of the fired empty cases will have to be borne by the approved tenders (Purchaser).

The tenderers hereby notified that every condition as laid down in the various clauses of the tender notice above should be strictly followed, failing which tenders are liable to be rejected straightway.
